# 1. For the Post of Case Registry Assistant:

#### Eligibility Criteria:

 The candidate must have passed Bachelor Degree with minimum 50% marks in aggregate from a recognized University/ Institution with PGDCA/ diploma in Computer Application (01 year duration).

# Age relaxation and Additional weightage of Marks for the applicants who are employees of OSH & FWS Society.
