Information on the vacancy position of Inspector of Cooperative Societies for approval of Empowered Committee.

The proposal for approval of EC for recruitment of 12 posts of ICS has been submitted to Government vide this Directorate letter No-16283 dated 15.09.2023 & letter No-21663 dated 22.12.2023. At the time of submission of proposal, 71 posts of ICS were remained vacant against the sanctioned strength of 297 posts of ICS (From Direct recruitment quota). Out of the vacancy post of 71 ICS requisition was placed for 59 posts of ICS to Odisha Staff Selection Commission, Bhubaneswar. So at that time 12 posts of ICS were remained clear vacancy. Due to abolition of 222 posts of ICS certain discrepancies was arisen in the categories of posts of ICS while submitting the above proposal i.e. 6 post of ICS shows excess in UR category and 5 posts of SC category & 13 posts of ST Category remained vacant. In order to balance the total sanction strength of 297 posts (From Direct recruitment quota) of ICS category wise proposal submitted for approval of EC for recruitment of 12 posts of ICS (i.e. SC-3 posts & ST -9 posts). In the meantime, Odisha Staff Selection Commission, Bhubaneswar have sponsored the name of 59 candidates for appointment to the post of ICS vide their Notification No. IIE (Conf) -62/23-09 (C)/OSSC Dated. 02.01.2024. Out of the sponsored 59 candidates, 45 candidates have joined the post ICS in the year 2024.

Against the sanctioned strength of 594 posts of ICS, 246 ICS (1-Selection & 245-Direct) are in position as on 15.05.2024 and 348 posts of ICS have remained vacant. Out of the vacancies of 348 posts, there are 52 vacancies in direct requirement quota and 296 vacancies in selection quota. Now approval of EC is required for filling up of total vacancy of 52 (UR-11+SC-10+ ST-21+ SEBC-10) posts of ICS from direct recruitment quota. The detail position of the ICS is as follows.
