 Place of Interview: In the office of the Central Instrumentation Facility (CIF), OUAT, Bhubaneswar-3

Eligibility: Essential:

- A minimum second-class Bachelor's degree in Chemistry/Biochemistry/Environmental Science with at least 55% marks.
- A Master's Degree in Chemistry/Biochemistry/Environmental Science with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in the concerned subjects from a reputed university or organization.

Desirable:

- Research experience of 1-2 years in Research Laboratory /University
- Experience in handling spectroscopy and chromatography instruments such as ICP-OES, GCMSMS, LCMSMS, HPTLC, FTIR, UV VIS Spectrophotometer, CHNS analyser etc.
- Participation in workshops/training programs of laboratory techniques and instrumentation.

Age limit:

 21 – 45 years, as on date of walk-in interview (Age relaxation SC/ST/ OBC/PWD/ Women and other exempted categories as per ICAR / GOI guidelines).

Place of posting:

Central Instrumentation Facility (CIF) of OUAT, under the administrative control of the DEAN,
College of Agricultural Engineering and Technology, Odisha University of Agriculture and Technology, Bhubaneswar.

Nature of Job:

• The incumbent will have to operate different equipment available at the CIF and analyse the samples received.

Requirements for appearing the interview:

- Candidates fulfilling the essential criteria/qualification only need to attend the walk-in interview along with their credentials as per the format given at ANNEXURE-1(duly signed) along with self-attested copies of all the testimonials and age proof with a passport size photograph and experience certificate (if any).
- 2. The candidate must also bring all the original certificates from matriculation onwards and experience certificate (if any) with them, without which the candidate will not be allowed for appearing the interview.
- 3. The candidates called for interview are not entitled for any TA/DA. They will appear the interview at their own cost.
- 4. Candidates should also bring no objection certificate from the Employer in case he/she is employed elsewhere.
- 5. Written examination may be conducted if the number of candidates is equal to or more than six (6 nos.).
- 6. Concealing of facts or canvassing in any form shall lead to disqualification of the candidature or termination even after engagement.
- 7. The final merit list/selection will be done on the basis of weightage on career, experience, personal interview (and the marks of the written examination if conducted for screening of candidates). In case written examination for screening is conducted only four candidates will be considered for interview on the basis of marks in written test).

Terms and conditions:

- 1. This engagement will be for a period of one year (1 Year) from the date of joining and may be extended further as per the requirement of CIF, OUAT as well as on the basis of satisfactory performance and due approval from the competent authority.
- 2. The engagement can be terminated at any time without assigning any reason thereof.
- The engagement will not entitle to any claim for regular service or any service benefit under the University for which an undertaking in non-judiciary stamped paper has to be submitted.
- 4. Upon being selected, the candidate should report for duty within fifteen (15) days of issue of the engagement order before the OIC, CIF, OUAT, failing which the engagement order shall stand automatically cancelled.
- 5. The selected analyst will be required to submit a medical fitness certificate from a physician before joining.
- 6. The performance of the analyst will be reviewed every month by the OIC, CIF, OUAT and the engagement may be terminated at any time without any notice, if the performance of the analyst is found unsatisfactory, failure to maintain discipline/ laboratory protocols.
- 7. In case the analyst intends to leave the engagement before completion of the tenure, then he/she has to inform the OIC one month prior to leaving.
- 8. In addition to all the above terms and conditions, the authority may prescribe some more conditions from time to time and all these will be binding on the analyst.

N.B. The date and time of the walk-in interview may be changed under administrative exigencies and any change will be notified on the website. So, the interested candidates are required to check the website (www.ouat.ac.in) for such updates.
